Dear Vendors,

Below are some basic expectations for our vendors.

- **All payments and completed forms MUST be returned before event to guarantee your space.**
- These forms do not allow for sub-letting of space nor is it transferable.
- To reserve space this application for commercial exhibitor MUST be completed, properly signed and returned with the required documentation and rental fee and early exit fee **\$50.00**. Must be 2 separate checks.
- All sales and political campaigning must be done from booth or in the space directly in front of the rented space. **No campaigning, advertising and/or selling while walking the grounds is allowed.**
- ALL Vendors MUST be OPEN/OPERATING during all POSTED Fair Hours.
- * NO REFUNDS for cancellations after August 15th.

The Fair Board Reserves the Right to limit the sale of any items that they deem inappropriate to the family atmosphere of the event. Any items found to be inappropriate, shall be immediately withdrawn from premises at the request of the Fair Board. If it's not removed immediately, the Fair Board may close booth without a refund.

Tables, and chairs are available for renting on a first come service. Power cords must be rented from us.

Vendors must supply the Blue Earth County Fair with proof of insurance or sign a insurance waive form, form ST19 (which can be found on our website) and checks for rental space and early exit deposit (early exit check will be held until end of the event, **vendors MUST pick up deposit check at the office before leaving**). **All completed in FULL paperwork and payments must be received before spot will be assigned.**

BOOTHS MUST BE IN PLACE ONE HOUR prior to opening to the public at 10:00 am and MUST not be taken down until closing at 4:00 pm.
